The role centres around the roadmap to closing the gap on eye health and will involve working closely with Aboriginal Communities across the region for better access to primary and specialist eye care.

The successful applicant will have knowledge and understanding of how best to consult and engage with Aboriginal Communities and will be able to demonstrate experience working in partnership with Aboriginal Communities. Familiarity with the health and community care systems is also important and an understanding of community networks and communication across the networks is essential.

The applicant will have project management experience, with good time management skills and will possess excellent written and verbal communication and interpersonal skills and be able to work effectively within a team environment.

The Project Officer will have capacity to take the lead on the eye health project:

- Designing, leading, implementing and evaluation change management in a complex service environment
- Working co-operatively and effectively with a range of agencies and services to enhance access to primary and specialist eye services
