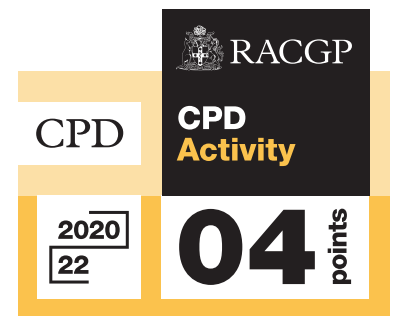
## INTERACTIVE WEBINAR

### Speaker | [A/Prof Jeremy Grummet MBBS, MS, FRACS](#)



A/Prof Jeremy Grummet is Clinical Associate Professor at Monash University, Director of Clinical Research at Alfred Health and supervises PhD and Master of Surgery students on MRI and PSMA PET in prostate cancer diagnosis. He has published numerous papers on the lack of sepsis in transperineal prostate biopsy, one paper, Sepsis and Superbugs, winning the 2015 British Journal of Urology Global Prize.

Jeremy was an invited plenary speaker at the 2017 AUA Meeting in Boston in the Crossfire Debate on transperineal biopsy, and invited author of the chapter How To Biopsy in Urologic Clinics of North America. He is also a leading advocate of TRexit, a global movement to end prostate biopsy performed via the transrectal approach.

Jeremy is a member of the EAU Guidelines Prostate Cancer Panel and co-founder of MRI PRO, the online trainer for reading prostate MRI, launched in 2018.

Jeremy is a member of Australian Urology Associates private practice and operates at Cabrini Malvern and Epworth Richmond.
